



## Call for Applications for Hunting & Trapping Marshalls

The Federation for Hunting & Conservation – Malta (FKNK) is seeking to recruit Hunting & Trapping Marshalls to work on part-time basis in the field (hunting and trapping zones) in Malta and Gozo during the forthcoming hunting and trapping open seasons.

This work requires high commitment and the selected persons will have to ensure to be available during the specific time period and to be able to dedicate their full attention to this work.

The selected candidates will be required to:

- Help the Police Authorities with the enforcement of the relative hunting and trapping regulations.
- Be fully conversant with and have up to date knowledge of the current hunting and trapping regulations.
- Attend an initial course covering all the policies, procedures and ethics involved in this support.
- Attend scheduled group meetings in order to communicate with each other and appraise the general progress of this project.

All the necessary communications equipment and resources will be provided.

Remuneration will be established at an hourly rate.

This venture will be launched as a pilot project after 31st January 2010 with the opening of the next hunting and trapping season, with the possibility of it being re-launched in the following open seasons. A detailed timetable of the working days and hours will be scheduled according to the demand.

### Eligible Candidates must be:

- Experienced in hunting and trapping related matters and governing regulations.
- In good physical state of health.
- Available during the hunting and trapping open seasons.
- Able to work diligently and independently with minimum of supervision.
- Committed to this work.
- In possession of a clean Police record.
- Possess a good command of the English language.

*Preference will be given to persons with first-hand experience in hunting and trapping affairs as well as persons with experience in disciplinary corps.*

Candidates will be required to sit for an interview.
