Prof. Edward Scicluna MEP also Joins “Sustainable Hunting” Intergroup...

Prof. Edward Scicluna MEP has become the fourth Maltese MEP to join the European Parliament Intergroup “Sustainable Hunting, Biodiversity, Rural Activities, Agriculture & Forestry” when this group was reconstituted for this European Parliament term.

Dr. John Attard Montalto MEP, who was the only Maltese MEP who had formed part of this Intergroup in the past European Parliament term was the first Maltese MEP to join the European Parliament Intergroup “Sustainable Hunting, Biodiversity, Rural Activities, Agriculture & Forestry” this time around, followed by MEPs, Dr. Simon Busuttil and Mr. David Casa.

The Federation for Hunting & Conservation – Malta (FKNK) is now very glad to note that as much as four out of the present five Maltese MEPs, have signed up for the group.

This situation places Malta as the EU Member State with the highest percentage of representation on this Intergroup, while the FKNK will continue to lobby Mr. Louis Grech MEP and Mr. Joseph Cuschieri who should soon become the sixth Maltese MEP, to also join.

Intergroups consist of MEPs from different Political Groups with a common interest in a particular subject. The “Sustainable Hunting” Intergroup established in 1985, is one of the oldest and most active in the European Parliament. As its name indicates, the Intergroup deals with issues for which the European Parliament is competent in the fields of hunting, wildlife management, angling, forestry, biodiversity, agriculture and nature conservation, taking account of public and wild animal health and welfare. The President-Coordinator of the Intergroup is Ms. Veronique Mathieu MEP, and the Secretariat is ensured by FACE (The Federation of Associations for Hunting & Conservation in the EU).

L-Ewroparlamentari I-Prof. Edward Scicluna sar ir-raba Ewroparlamentari Malti li nġhaqad mal-“Intergroup” fi hdan l-istess Parlament Ewropew, “Sustainable Hunting, Biodiversity, Rural Affairs, Agriculture & Forestry”.

L-Avvukat John Attard Montalto MEP, li kien l-uniku MEP Malti li kien parti f’dan l-Intergroup fl-aħħar term tal-Parlament Ewropew, kien l-ewwel Ewroparlamentari Malti li reġa issieheb din id-darba, u wara iffiraw għall-partecipazzjoni tagħhom iż-żewġ MEPs oħra Maltin, L-Avvukat Simon Busuttil u s-Sur David Ċasa.

L-Intergroup “Kaċċa Sostenibli” li kien gie imwaqqaf l-ewwel darba fl-1985, huwa wiehed mill-aktar antiki u mill-aktar attivi fil-Parlament Ewropew.
